Agreement

Article I: The data shall be used only for the purposes stated in the request.

Article II: It is strictly forbidden to share the data with anyone else without written request to and written permission from GLD.

Article III: The recipient is responsible for taking necessary measures to ensure that no individual, area, or country associated with the GLD data experiences harm because of how the data is stored, handled, or used. This includes, but is not limited to, obeying all relevant data protection and handling laws.

Article IV: GLD data must always be cited (in written papers, oral presentations, or other dissemination of results) as a source using the citation provided by GLD.

Article V: Upon getting access to GLD data, the user commits to submit a working paper to the GLD working paper series. Exceptions can be made upon agreement.

Article VI: The user is responsible for the validity of any subsequent analysis.

GLD Acknowledgements and Data Citation Protocol

The following citation and acknowledgements must be included on projects utilizing the provided GLD source data including, but not limited to, oral presentations, theses/dissertations, academic papers, and other forms of dissemination.

Acknowledgements

It is important for donors to be able to connect their funds to tangible outcomes, so please make sure to acknowledge the funders who supported your work.

It is also important to acknowledge all the critical non-author contributors such as colleagues, research associates, data analysts, administrators, translators, and survey firms. For many of these groups of individuals, acknowledgements provide the best record of their professional activities.

If you participated in the survey design, data collection, etc., then you **MUST** acknowledge the project funder(s) **AND** cite the data. If you are using the data as a third party, you are **not** expected to cite the donors but **MUST** cite the data.

NB: All who conducted research while supported as PhD students, post-doctoral fellows, or researchers hosted by GLD should acknowledge the 'Big VR' in their publications.
